Shared Branching – Coming Soon (First Quarter 2017!)

With Shared Branching, Your Credit Union will be where you want it – EVERYWHERE!

In early 2017, your Credit Union will begin participating in CO-OP Shared Branch network. This means that you will be able to conduct your financial transactions as if you were at the Sarasota Municipal Employees Credit Union location. There are more than 5,000 shared branches across the United States and international locations – Belgium (2), Germany (5), Guam (3), Italy (3), Netherlands (1) and the United Kingdom (3).

With Shared Branching, you will be able to perform the following transactions:

- Make Deposits.
- Withdrawal Cash.
- Conduct Account Inquiries.
- Make Loan Payments.
- Complete Transfers between accounts.

Be sure to check our lobby, website and Facebook page for further announcements regarding our LIVE date with Shared-Branching. This is just one more way that your Credit Union is providing you with the convenience that you deserve.

Wake up Your Dormant Account in 2017

If you have a dormant account at your Credit Union, you're neglecting an asset that could be working for you. Dormant accounts cost the Credit Union as well. When your account remains inactive we have to charge a fee. After an account is inactive for 12 months or has been considered abandoned for 5 years we have to send the account balance to the State of Florida. To avoid our dormant account fee or remittance of your money to the state, please make a deposit into your account at least once every 12 months. An easy way to remember is to reward yourself by making a deposit on your birthday!



ON THE MOVE

Whether you're headed to your second home for the season, downsizing or seeking space for your growing family, if you're on the move, please keep the Credit Union posted. We want to make sure important tax and other account information finds its way to you, so please advise us of a current mailing address.

Also, there is no need to close your account whether you are moving cross-town or cross-country. You can take the Credit Union with you. Your Credit Union debit cards and credit cards are accepted virtually everywhere and with e-Statements, our online Home Banking portal and other electronic services, the Credit Union is always a couple clicks away.
