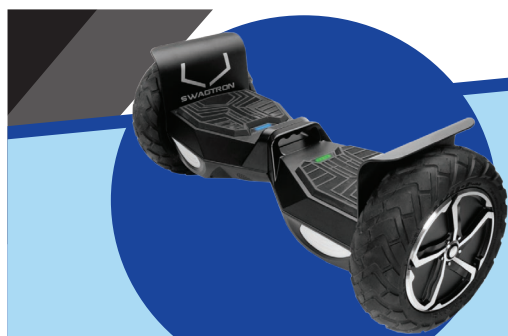

**Introducing our New VISA Cards!**

Your Credit Union is pleased to unveil its new VISA Platinum Credit Cards. The Platinum Card on the left are for those members who carry a balance each month and want a lower interest rate. The fixed rates range from 9.74% to 17.24% based on your credit score.

For those members who want to earn rewards, you will want to apply for the Platinum Rewards card. You will earn Scorecard Rewards which can be redeemed for brand-name merchandise to travel options. The fixed rates on the Platinum Rewards card range from 10.99% to 17.99% based on your credit score.

Those members who had a VISA Card with the Credit Union prior to May 20, 2018, have automatically been transferred to the VISA Platinum Rewards Card at a fixed rate of 10.9%.
